

TRS® Filing Process Agreement — Effective February 17, 2019

1. The undersigned Group/Company (Participant) is a signatory to the Automobile Subrogation Arbitration Agreement (Auto Forum Agreement).
2. By signing this TRS Filing Process Agreement (TRS Agreement), the Participant accepts and binds itself to the terms and conditions of this TRS Agreement in addition to the Auto Forum Agreement.
3. To assist Arbitration Forums, Inc. (AF) in developing improved technology and methods of delivering state-of-the-art dispute resolution services, Participant agrees to utilize AF's TRS Automobile Arbitration Filing Process (TRS) to arbitrate cases against other Auto Forum Agreement members that also signed the TRS Agreement.
4. TRS arbitrations are restricted to disputes that could be filed pursuant to the Auto Forum Agreement, except for the following modifications to the Arbitration Forums, Inc. Rules:
 - (a) All parties must be signatories to the TRS Agreement.
 - (b) All TRS filings must be initiated through E-Subro Hub.
 - (c) A filing cannot involve the same accident, occurrence, or event that is already pending in AF's Online Filing system (OLF).
 - (d) All counterclaims between the parties related to the initial TRS filing must be filed in TRS.
 - (e) Where a company files a counterclaim in TRS seeking recovery of damages paid after an initial filing has been heard, the initial TRS liability decision will be res judicata. The liability decision will not be res judicata to any other claim arising out of the loss filed in TRS or any other forum (modifies Rule 2-2).
 - (f) There is no allowance to request a reschedule of the Materials Due Date (modifies Rule 2-9).
 - (g) There is no allowance to request a one-year deferment of a case (modifies Rule 2-10).
5. Participant acknowledges AF's authority to make appropriate Rules for TRS arbitrations and expressly consents to the TRS Rules set forth in paragraph 4 of this TRS Agreement. Participant agrees to accept and abide by future changes to the TRS Rules or the TRS Agreement (without further signature); or withdraw from the TRS Agreement as set forth in paragraph 6. Upon the effective date of the current TRS Agreement, all prior TRS Agreements are deemed to be amended and modified in accordance with the terms of the current TRS Agreement.
6. Any participating company may withdraw from this TRS Agreement by notice in writing to Arbitration Forums, Inc. Withdrawal will become effective forty-five (45) calendar days after receipt of such notice. Any cases pending in the TRS filing system on the effective date of withdrawal will be processed, and the decisions will be final and binding.
